GENERAL INFORMATION, CONDITIONS AND REGULATIONS

1. SEASON

Seasonal campsites are available from May 13, 2011 until September 12, 2011. Twenty-five electric sites and two non-electric sites are available for seasonal camping.

2. SEASONAL CAMPING FEES (GST included)	\$1500.00	30 amp electric site

3. APPLICATION COMPLETION

- a) Seasonal campsites will be made available to Saskatchewan residents first.
- b) One application only per immediate family is permitted.
- c) A cheque, postdated no later than draw date, payable to Fort Qu'Appelle Recreation & Parks Commission is required with the application. Send two or three cheques if choosing 30 amp, 15 amp and/or non-electric.
- d) Applications will be received until 4:00 PM Monday April 11, 2011.
- e) Applications are to be sent to Fort Qu'Appelle Recreation & Parks Commission, Box 1547, Fort Qu'Appelle, SK S0G 1S0. Office is located in the Rexentre at 560 – 4th Street East.

4. ALLOCATION OF CAMPSITES

- a) Seasonal campsites will be allocated to qualified applicants by a public draw system held at the Rexentre on Tuesday April 12, 2011 at 9:00 AM. Cheques for successful applicants will be deposited April 13, 2011.
- b) At the discretion of Recreation & Parks Commission they reserve the right to screen applications eg. problems in past years.
- c) Successful applicants will be notified by phone. If applicant decides to decline seasonal site after it has been accepted and cheque deposited, fees will be returned less 10% administration cost prior to May 15th, 2011.
- d) Cheques will be shredded for unsuccessful applicants unless we are advised differently.

5. GENERAL CONDITIONS:

- a) Campground services may be reduced prior to Victoria Day weekend and after Labour Day weekend or longer dependant on weather, other conditions including flooding.
- b) Absolutely no elm wood allowed – eviction applies/no warnings/no refund.
- c) Only one camping unit (tent, tent trailer, camper, truck camper, camping trailer, or motor home) is allowed per campsite. Mobile homes and bunkhouse type trailers are not allowed. All units must be maintained so as not to detract from the park setting. Due to campsite size, length restrictions may apply.
- d) One small tent per single site for accommodating dependent children and one screened tent for meal purposes may be allowed with prior approval of the Campground Attendant or designate depending on the size of the campsite. No other structures or site alterations are permitted. Seasonal campers shall maintain the camping site and camping unit in a condition acceptable to the Campground Attendant and Recreation & Parks Commission.
- e) Visitors may no longer share the same campsite even if there is sufficient room.

- f) Only two vehicles are allowed at each camping site at any time. Any vehicle detachable from the camping unit is considered one of the two vehicles. One watercraft/site is allowed. Visitors are to park their vehicles in the parking lot.
- g) One picnic table will be supplied per campsite.
- h) Lights are restricted to a maximum of 12 patio lights (1 string) per site, CSA approved.
- i) Major appliances are restricted to those fixed in the camping unit/contained within the original unit's construction.
- j) Greywater must be contained and disposed of at trailer disposal site. The dumping of greywater on the ground is prohibited.
- k) All camping units, other than tents and truck campers, shall be legally registered and display a current valid license plate at all times when on Campground lands.
- l) Permit holders shall not rent, sell, sublet, assign or otherwise transfer the assigned site. Site is for name on application only, not extended family. Fees paid for seasonal camping are not refundable.
- m) All camping units must be movable upon 24 hours notice. At the end of seasonal camping unit must be removed from the campsite. Anyone wanting to stay after that date will be charged a per night fee. You are not allowed to move in to your designated site prior to the seasonal date. Winter trailer storage may be possible.
- n) The permit holder, their family and guests shall comply at all times with all permit conditions and regulations. The permit holder is responsible for the conduct and behavior of their families and guests. Everyone must observe all campground regulations and conditions. Rowdy behavior or excessive noise is not permitted at any time.
- o) Pets must be kept leashed and attended at all times. Pet owners must ensure that pet litter is cleaned up. Pets are not permitted in public structures, on beach and in swimming area. Please be considerate of your neighbours.
- p) Alcoholic beverages may be consumed in the permit holder's camping unit and on their assigned site, in accordance with The Alcohol and Gaming Regulations Act, as per Section 107 (1) per 139(1).
- q) Hot tubs are not allowed in Campground. No one is allowed in panel boxes to change breakers or alter in any way.
- r) Seasonal campers are expected to use their site regularly.
- s) The office and/or Campground Attendant is to be notified if the camping unit is to be removed from the seasonal site for any time period. Fort Qu'Appelle Recreation & Parks Commission reserves the right to assign the campsite to another camper for the vacated period. 24 hours notice is required when returning to a seasonal site.
- t) No person shall carry on a business or occupation in the Campground.
- u) No open fires. Fires are allowed in provided BBQ's and firepits only.
- v) Quiet time is 11:00 PM – 6:00 AM
- w) When vacating the campsite at the end of the season, the permittee must remove all personal property and restore the site to its original condition. Failure to do so will result in surcharges.
- x) Failure to comply with the above conditions may result in eviction and/or loss of the campsite for the season and/or following years.
