

## BYLAW NO. 19-2022 THE TRAFFIC BYLAW

**A bylaw of the Town of Fort Qu'Appelle to supplement the Highway Traffic regulating traffic upon the public streets of the Town of Fort Qu'Appelle and preserving order therein.**

The Council of the Town of Fort Qu'Appelle in the Province of Saskatchewan enacts as follows:

### PART I

1. In this bylaw:

- (a) **“Alley”** shall mean a public street intended primarily to give access to the rear of property.
- (b) **“Alley crossing”** shall mean that portion of a sidewalk within the boundaries of the alley projected.
- (c) **“Bicycle”** – a vehicle for the carriage of persons, which is propelled by human power, having two tandem wheels either of which is over twenty (20) inches in diameter, and including any device adapted from a bicycle by the addition of one or more wheels.
- (d) **“Council of the Town”** shall mean the Council for the Town of Fort Qu'Appelle.
- (e) **“Curb”** shall mean the dividing line of the street between that part of the street intended for use of vehicles and the part of the street intended for use by pedestrians, whether marked with a curbstone or not.
- (f) **“Double parking”** means the parking of a vehicle on a street parallel to a vehicle parked beside the curb in a parking area, or parking to the rear of any vehicle that is angle parked at the curb in a parking area.
- (g) **“Driver”** shall mean a person leading or riding or driving one or more horses or the operator of a vehicle.
- (h) **“Emergency vehicle”** shall mean a fire engine, fire department apparatus, ambulance and police motor vehicles.
- (i) **“Garage”** shall mean any building or part of a building where motor vehicles are stored or repaired, and includes an automobile salesroom or automobile showroom.
- (j) **“Highway Traffic Act”** Any reference to the *Highway Traffic Act* in this bylaw shall be deemed to refer to the *Highway Traffic Act* in effect in the Province of Saskatchewan.

- (k) **“Lane Street”** a street divided into two or more marked lanes for vehicular traffic.
- (l) **“Motor vehicle”** means a motor vehicle as defined in The Highway Traffic Act.
- (m) **“One-way Street”** and **“one-way lane”** means a street or lane, as the case may be, designated as one upon which vehicles shall move only in the direction indicated.
- (n) **“Owner”** shall mean in the case of a motor vehicle required to be registered under the *Highway Traffic Act* the person in whose name the vehicle is registered and shall include a corporation, association or other aggregation of individuals which own or control said motor vehicle and in the case of vehicles other than motor vehicles shall mean and include such person, corporation, association or other aggregation of individuals which or who is entitled to the possession and/or property in the vehicle.
- (o) **“Parade”** means any procession of body of pedestrians (except members of the armed forces) numbering more than twenty-five (25), standing, marching or walking on any street or sidewalk, or any group of vehicles numbering ten (10) or more (except funeral processions) standing or moving on any street.
- (p) **“Park”** or **“parked”** means the standing of any vehicle in a highway either in charge of driver or without such driver for a longer period than is necessary to actually load or unload said vehicle or take on or let off passengers.
- (q) **“Pedestrian”** shall mean any person on foot and shall include a baby carriage or invalid’s chair.
- (r) **“Police Officer”** means a member of The Royal Canadian Mounted Police, or a person designated by the Police Act.
- (s) **“Private road or driveway”** every road or driveway not open to the use of the public for the purpose of vehicular travel.
- (t) **“Recreation Vehicle”** shall mean any travel trailer, 5<sup>th</sup> wheel trailer, motor home, boat or any trailer used in the conveyance of recreation vehicles.
- (u) **“Sidewalk”** includes that portion of a street used exclusively for pedestrians.
- (v) **“Sidewalk crossing”** the portion of a sidewalk permanently improved or designated for the passage of vehicular traffic.
- (w) **“Stop”** means a complete cessation of movement.
- (x) **“Street”** shall mean that portion of every highway, public road, street, avenue, alley, bridge, park, drive or public place in the town intended for use by vehicles.
- (y) **“Town”** shall mean the Town of Fort Qu’Appelle.

(z) **“Traffic”** means pedestrians, ridden or herded animals, vehicles, and other conveyances, either singly or together while using any highway.

(aa) **“Traffic sign”** means any sign, signal marking, or other device, placed pointed or erected for the guidance regulation, warning, direction, or prohibition of traffic, parking, or stopping.

(bb) **“Vehicle”** means a vehicle as defined in *The Highway Traffic Act*.

2. Any other words shall insofar as not inconsistent with this bylaw, have the same meaning as in the *Highway Traffic Act*.

## **PART II**

### **AUTHORITY OF THE POLICE-TRAFFIC SIGNS AND SIGNALS**

#### **Obedience to Police**

3. The police officers of the Town are hereby authorized to direct all traffic in accordance with the provisions of this bylaw, or in emergencies as public safety or public convenience may require. No person shall neglect or refuse to comply with any order, signal or direction of a police officer.
4. No person shall direct or attempt to direct traffic unless authorized to do so by a police officer.

#### **Push-carts and Animals**

5. Every person propelling any push-cart or riding an animal upon a roadway and every person driving any animal shall be subject to the provision of this bylaw applicable to the operator of any vehicle, except those provisions of this bylaw with reference to the equipment of vehicles, and except those provisions which by their very nature can have no application.

#### **Traffic Signs and Signals**

6. The Council of the Town may by resolution authorize the erection of such signs and signals as they may deem necessary for the proper carrying out of the provisions of this bylaw. Such signs shall be of a design as set out in the schedule marked “A” hereunto attached or as the same shall be, from time to time, by resolution of Council of the Town amended or altered.

#### **Obedience to Traffic Signs and Signals**

7. (1) No operator of a vehicle and no pedestrian shall disobey the instructions of any traffic sign or signal, unless otherwise directed by a Police officer.  
  
(2) Violations under subsection one (1) with respect to stop signs or traffic control signals exhibiting different coloured lights shall constitute a violation of the provisions of the Highway Traffic Act of the Province of Saskatchewan.

### **Unauthorized Signs and Signals Prohibited**

8. No person shall place or maintain or display upon or in view of any street, any sign, signal or device which purports to be or is an imitation of or resembles a traffic sign or signal, or which attempts to direct the movement of traffic, or which hides from view any traffic signal or sign. Any police officer, the Town's Bylaw Officer, the Town's Public Works Manager, or the Town's Chief Administrative Officer is hereby empowered to remove or cause to be removed, without notice, every such prohibited sign, signal or device.

### **Interference with Traffic Signs Prohibited**

9. No person shall willfully, deface, injure, move, obstruct or interfere with any traffic signs, signals or devices.

### **Parking**

10. Any police officer of the Town shall have power to prohibit the parking of a motor vehicle on any provincial highway or part of a provincial highway in the Town.

### **Removal of Vehicles**

11. (1) A police officer shall have the right to remove to a proper place any vehicle having no person in charge thereof which he may find in such a position as to constitute an obstruction or interference with or danger to other vehicles or traffic on the streets.  
  
(2) The costs of such removal and storage, if any, shall be paid by the owner or operator of such vehicle before such vehicle is released.

## **PART III**

### **PEDESTRIANS' RIGHTS AND DUTIES**

#### **Pedestrians Soliciting Rides**

12. No person shall stand in a street for the purpose of soliciting a ride from the owner of any private vehicle.

#### **Obstructing Sidewalk or Roadway**

13. No person shall obstruct the free passage of traffic on any sidewalk or street after having been requested to move on by any police officer or other person duly authorized to do so.

### **Instructions for Permits for Parades and Processions**

14. (1) No parade shall be held without first obtaining written permissions from the Council of the Town. Every person participating in a parade for which no permit has been granted or not complying with the provision of this bylaw shall be guilty of a breach of this bylaw.
- (2) Application for a permit for a parade shall be made in writing to the Council of the Town and required to provide the nature of the parade, the intended route, the number of persons and vehicles expected to take part, and the time which is expected will be required for the parade to pass a given point.
- (3) All applications or permits requesting police presence shall be submitted to the Chief Police Officer far enough ahead of the day of the parade to allow the Chief Police Officer staff ample time to arrange time allowed shall be in the discretion of the Chief Police Officer provide that at least twenty-four (24) hours shall be allowed unless the Chief Police Officer agrees to accept shorter notice.
- (4) All vehicles in a funeral procession shall have their headlights on irrespective of the time of day and no person driving a vehicle shall drive it though or cause it to obstruct or interfere with a funeral procession.

### **Persons in Prohibited Parades Liable**

15. Any person taking part in or adhering to any parade or procession held or conducted in violation of this bylaw shall be guilty of an offence and liable to the penalties provided in the same manner as if such person had been in charge of the parade procession.

### **Street Preaching**

16. Nothing in paragraph 13 hereof shall be construed as prohibiting the congregation of individuals to attend and listen to street preaching, on any street approved in writing by the Council of the Town so long as the proceedings thereat are peaceable and orderly and sufficient space is left on both on the sidewalks and roadway to accommodate the ordinary traffic on the sidewalks and roadway upon which such preaching takes place, providing however, that the preacher and all persons congregated with him shall, upon being requested by a police officer so to do, forthwith move from such street.

### **Unnecessary Noise Prohibited**

17. (1) No person shall make any unnecessary noise on any public street or in any public place to startle or distract a person operating a motor vehicle.
- (2) Use of engine retarder brakes prohibited within the limits of the Town of Fort Qu'Appelle.

### **Running and Inconveniencing Pedestrians**

18. No person shall race on the street or sidewalks, or crowd or jostle other pedestrians so as to create discomfort or confusion.

**Pedestrian to Yield Right-of-Way**

19. A pedestrian crossing or walking on a street at a point other than within a marked crosswalk or unmarked crosswalk shall yield the right-of-way to all vehicles upon the street, provided that this provision shall not relieve the driver of a vehicle from the duty to exercise due care for the safety of pedestrians.

**PART IV**

**STOPPING, STANDING AND PARKING**

**Stopping Prohibited in Specified Places**

20. No operator of a vehicle shall stop such vehicle in any of the following places, except when necessary to avoid collision or conflict with other traffic or in compliance with the directions of a police officer or traffic officer or traffic sign or signals:

- (a) within an intersection;
- (b) on a sidewalk or boulevard;
- (c) on a crosswalk;
- (d) within ten (10) feet of block corners at intersections except at alleys;
- (e) within fifteen (15) feet of the driveway entrance to any fire station;
- (f) within five (5) feet of the entrance of any alley;
- (g) within five (5) feet of the entrance to a fire hydrant;
- (h) within ten (10) feet of an entrance or exit of a Bingo Hall;
- (i) with its left-hand side to the curb, except on on-way;
- (j) in marked school bus loading and unloading zones.

**Parking**

21. (1) No operator of a vehicle shall park said vehicle in any of the following places:

- (a) in any alley;
- (b) within fifteen (15) feet of entrance of any alley on all streets where angle parking is permitted, or within five (5) feet of entrance of any alley where parallel parking is permitted;

(c) in such a manner as to obstruct any private driveway;

(d) in any place mentioned in Section 20.

(2) No operator of a vehicle shall park such vehicle at any place where traffic signs have been placed prohibiting parking.

(3) No operator of a motor vehicle having a manufacturer's rated capacity in excess of one-half tonne, shall park such vehicle for the purpose of unloading at any time in the travel portion on any of the following streets:

(On Broadway Street, between intersections of Bay Avenue and Neeping Avenue.)

22. No person shall park any vehicle on Broadway Street between Bay Avenue and Neeping Avenue or Company Avenue between the East and West lane in Block 3 to the East and West lane in Block 4, for a period longer than two (2) hours except during the hours of 6:00 P.M. and 9:00 A.M. and on Sundays and holidays.

#### **Parking Time Limited in Certain Places**

23. (1) No person shall park any vehicle for a longer time on any roadway than allowed by traffic signs or signals.

(2) No Recreation Vehicle shall be parked on a residential street continuously for any period exceeding seventy-two (72) hours. A daily penalty of \$50.00 will be assessed against the owner of the vehicle for each day the vehicle is in contravention of this bylaw.

#### **Method of Parking**

24. (1) Except when necessary in obedience to traffic regulations or traffic signs, no operator of a vehicle shall stop, stand or park any vehicle in a roadway other than parallel with the curb and with the right-hand wheels of the vehicle within twelve (12) inches of the edge of the roadway or stationary object thereon such as telephone pole, except as provided in the following:

(a) upon one-way streets; where either side of the vehicle may be towards the curb;

(b) upon all of the following streets all vehicles shall be parked at an angle with the curb of between forty (40) and fifty (50) degrees and with the right front wheel not more than twelve (12) inches from the edge of the roadway;

Both sides of Broadway Street from Neeping Avenue to Bay Avenue.

West side Company Avenue between Broadway Street and 4<sup>th</sup> Street.

West side Company Avenue between 3<sup>rd</sup> Street and East West lane in Block 3.

East side Company Avenue between Broadway Street and East West lane in Block 3.

North side Broadway Street between Bay Avenue and Central Avenue.

East side Segwun Avenue between Broadway Street and 4<sup>th</sup> Street.

West side Pasqua Street North between 2<sup>nd</sup> Street and 3<sup>rd</sup> Street.

- (2) No motor vehicle shall be parked on a street unless it has displayed license plates for the current year.
- (3) No operator of a vehicle shall park such vehicle in any one parking place on any street continuously for any period exceeding seventy-two (72) hours.
- (4) Any vehicle parked, placed or left in any street contrary to subsection (3) above or to police signs, may be removed by any town official or town employee and such removal shall be at the expense and risk of the owner of such vehicle.
- (5) Any police officer is hereby authorized to issue special permits when, in his opinion, it is advisable allowing persons to stand vehicles otherwise than as herein provided for in order to load or unload merchandise or materials.

#### **Unattended Motor Vehicles**

25. (1) No owner of a motor vehicle and no person in charge of a motor vehicle shall allow such motor vehicle to be left attended on any public highway within the Town limits while the engine of such motor vehicle is running or while the keys are in the ignition.
- (2) The provisions of subsection (1) shall not apply when a vehicle has been parked with the emergency brake set and with the engine running when such vehicle has all the doors properly locked and with all windows intact and secure.

#### **No Immobilized Vehicles on Highway**

26. No person shall leave any vehicle unattended for more than two hours or as felt suitable by Council on any highway if the vehicle has been placed on a jack or jacks and one or more wheels have been removed from it or part of the vehicle has been raised.

#### **General Standing Prohibitions**

27. No person shall open the door of a motor vehicle on the side available to moving traffic unless and until it is reasonably safe to do so, nor shall any person leave a door open upon a side of a vehicle available to moving traffic for a period of time longer than necessary to load or unload passengers.

#### **Parking Vehicles for Sale Prohibited**

28. No person shall park upon a street or boulevard any vehicle displayed for sale.



**Parking Vehicles on Private Property Prohibited**

29. No operator of a vehicle shall park said vehicle in any private parking place or on any private property of which he or she is not the owner, occupant, licensee or permittee except with the consent of said owner, occupant, licensee or permittee.

**PART V**

**RULES FOR DRIVING**

**Drive on Right Side of Street**

30. Where two separate roadways are provided on any street, the operator of the vehicle shall drive only on the right-hand roadway.

**Backing Vehicles Prohibited**

31. (1) No driver of a vehicle shall back same around the corner of a land, street or highway intersection or along any street, except when reasonably necessary in entering or leaving a parking space.

(2) Every driver of a vehicle while backing shall exercise due care to avoid accidents.

**Control of Vehicles**

32. No person shall remove their hands from the steering apparatus of any vehicle in motion.

**Overtaking a Vehicle**

33. The operator of any vehicle overtaking another vehicle proceeding in the same direction shall pass to the left at a safe distance to the side of the overtaken vehicle and shall not cut in front of the latter until safely clear of the overtaken vehicle.

**One-Way Streets**

34. Every street or portion thereof set out in "Schedule B" attached hereto and forming part of this Bylaw are designated as one-way streets and the erection of appropriate signs on said streets is hereby authorized.

**Operator to Give Way to Overtaking Vehicles**

35. No operator of a vehicle shall deviate from their direct line of travel without ascertaining that such movement can be made with safety to other vehicles approaching from the rear and about to overtake and pass such first mentioned vehicle.

### **Space Between Moving Vehicles**

36. A vehicle travelling behind other traffic shall preserve sufficient interval to enable the vehicle to stop without accident in the event of any stop on the part of the leading traffic.

### **Weather Condition Affecting Streets**

37. When water, mud or slush is lying on any street the driver of every motor vehicle thereon shall so reduce the speed of their motor vehicle to avoid splashing any pedestrian using the sidewalk or within the boundary of a marked or unmarked crosswalk.

### **Turning Signs**

38. Wherever signs have been placed directing traffic, the operator shall follow the line as directed by such signs.

### **“U” Turns**

39. No operator of any vehicle shall turn such vehicle so as to proceed in the opposite direction at any point.

(a) where traffic is controlled by a police officer;

(b) except at an intersection of street, neither of which is an alley where no traffic sign or signal has been placed prohibiting such “U” turns.

### **Causing Excessive Noise**

40. (1) No person shall create or cause the emission of any loud and unnecessary noise from a motor vehicle, a part of a motor vehicle or any thing or substance that the motor vehicle comes into contact with.

(2) No person shall operate a motor vehicle on any street, avenue or lane at any time in the Town of Fort Qu’Appelle in such manner as to cause the wheels of said motor vehicle to spin, whereby foreign objects may be thrown from the said wheels of the said motor vehicle thereby creating a nuisance.

### **Seizure of Vehicles**

41. Any police officer or constable may, without warrant, seize any vehicle which is being operated or moved in the Town of Fort Qu’Appelle in violation of any of the provisions of this bylaw and may retain the same in custody pending the disposition of a charge in respect of said violation, which charge shall be proceeded with promptly.

### **Cross Yellow Solid Lines**

42. (1) No person operating a vehicle shall cross any double solid yellow center line on any public street or highway in the municipality.

(2) No person operating a vehicle shall cross any single solid yellow center line on a public street or highway except for the purpose of turning left at an intersection or curb crossing or backing from a curb crossing.

#### **Entering Traffic Stream**

43. The driver of a vehicle entering the flow of traffic from a standing position at the curb or from an alley, garage or driveway, shall yield the right-of-way to the other vehicles using the street.

#### **Traffic Obstruction**

44. No vehicle shall be operated or allowed to remain upon any street so as to be an unreasonable obstruction to the traffic thereon.

#### **Vehicles Backed to Curb**

45. No driver of a vehicle, semi-trailer or trailer combination shall stand the vehicle back up to the curb except while actually loading or unloading and if the vehicle is a semi-trailer combination, the motor vehicle or truck tractor unit thereof must stand parallel to the curb and faced in the direction of the going traffic, but no vehicle shall stand so backed up that it obstructs the free passage of traffic lawfully using the said half of the roadway in which the vehicle is standing and forces it to cross the centre lane of the roadway in order to pass.

#### **Vehicles not to be Driven on Sidewalks or Boulevard**

46. No operator of a vehicle shall drive within any sidewalk or boulevard area except at a permanent or temporary driveway, not upon any pedestrian path in a public park.

#### **Speed Limit**

47. The speed limit in the Town of Fort Qu'Appelle shall be forty (40) kilometers per hour unless otherwise posted Provincial Highways excluded. The speed limit in school zones shall be thirty (30) kilometers per hour.

#### **Vehicles not to Drive on Fire Hoses**

48. No operator of any vehicle shall drive over any unprotected hose of the fire department without the consent of the Fire Chief or the Assistant in command or any police officer.

#### **Cruising**

49. No driver of a public passenger vehicle shall solicit business while travelling on a roadway; nor shall an operator or passenger of any vehicle annoy any person by soliciting or enticing any person to his vehicle.

### **Unattended Animals**

50. No person shall leave any horse or mule unattended in any street without having securely fastened said animal.

### **Use of Coasters, Sleds and Similar Devices**

51. No person shall coast or ride downhill on a sled or other similar device upon any street not designated by signs for that purpose.

### **Emergency Vehicles**

52. (1) Emergency vehicles, when on emergency duty only and when continuously sounding a siren or horn shall not be bound by the speed limit provided for in this bylaw.

(2) This section shall not operate to relieve the driver of an authorized emergency vehicle from the duty to drive with due regard for the safety of all persons using the streets or highways.

(3) No vehicle shall follow any fire engine or fire department (150) meters.

(4) The driver or operator of any vehicle on the approach of an emergency vehicle shall immediately draw as near as practicable to and park at the right-hand curb and remain there until such emergency vehicle has passed.

## **PART IV**

### **REGULATIONS RESPECTING OPERATORS AND THE EQUIPMENT AND CONDITION OF VEHICLES**

#### **Towing Vehicles**

53. (1) No person shall tow any motor vehicle upon any roadway if the connection is so arranged that the towing vehicle and the vehicle being towed are separated by more than 2.5 meters.

(2) No Person shall push any vehicle in the Town of Fort Qu'Appelle at a speed greater than thirty (30) kilometer per hour.

54. Reserved.

#### **Wheel Construction**

55. No vehicle shall be permitted on the town streets, alleys or bridges, the face of the wheels of which are fitted with any appliances that would unduly injure or destroy the surfaces. All vehicles operated over town streets, alleys or bridges, must have wheels in good repair. Vehicles fitted with rubber tires whether solid or pneumatic must have the tires in place in good condition and properly inflated. No wheels shall be permitted to run on any paved surface that has the tire of same removed or in bad repair.

### **Weight Restrictions – Truck Routes**

56. (1) No person shall operate a vehicle or a combination of vehicles when the combined gross weight of the vehicle(s) with or without a load excess 4,000 kg or over 1 tonne by MFG rating, except on a highway within the municipality designated as a Heavy Vehicle Route as listed in Schedule C.
- (2) Subject to subsection (1), no person shall operate a vehicle or a combination of vehicles when the combined gross weight of the vehicle(s) with out without a load exceeds 35 tonnes on any highway within the municipality.
- (3) Subsections (1) and (2) shall not apply to vehicles making delivery on any highway in the municipality provided that the operator of the vehicle(s) uses the most direct route from and to the heavy vehicle route, as listed in Schedule C.
- (4) The provisions of The Police Act and The Highway Traffic Act shall apply to the operators of vehicles referred to in subsections (1) and (2).
- (5) The maximum gross vehicle weights provided in subsections 56(1) shall not apply to;
- (a) school buses used for public transportation; and
  - (b) emergency vehicles.

### **Loading**

57. (1) All material of any kind being transported over town streets, bridges, or alleys must be transported in such manner and in such containers that no part of the material shall find its way to the street while the same is in transit. Should any material be split upon the street it shall immediately be removed by the person in charge of said material so that the street shall be in as cleanly and useable state as before the material was split. The owner of any vehicle shall also be responsible for any violation of this section.
- (2) No person shall operate any vehicle transporting ashes, garbage, trade waste, refuse or debris of any kind or description whatsoever along or over any highway, street, lane or bridge in the Town of Fort Qu'Appelle unless the load in such manner that it shall be impossible for any part of the load of the said vehicle to find its way to the roadway.

## **PART VII**

### **STREET AND SIDEWALK OBSTRUCTION**

#### **Street Openings and Storage of Material**

58. No person shall perform any work in any street causing obstruction to traffic without first securing a permit from a police officer, or the Clerk of the Town of Fort Qu'Appelle.

### **Used of Barricaded Streets Forbidden**

59. No person shall drive through or upon any street or portion thereof which roped or barricade or where there is a notice posted prohibiting the use of the street.

### **Riding and Driving on Sidewalks Prohibited Except with Permission of Police Department**

60. (1) No person shall ride, drive, lead or back any horse or vehicle along or across any concrete, wood ash or cinder sidewalk except at a regular crossing unless with the written permission of a police officer in case he or she is satisfied that due precautions have been or will be taken by the applicant to protect the sidewalk from injury and the use thereof for such purpose will not cause any unwarranted obstruction to pedestrians.

### **Dilapidated Vehicles Not to be Driven**

61. No person shall drive or conduct any vehicle so constructed or loaded as to be likely to occasion delay in traffic or cause accident or injury to any person or thing.

### **Horses or Cattle at Large**

62. No person shall suffer or permit any horse or cattle to run at large or to stand in any street without being sufficiently secured to prevent its running away.

### **Immoderate Riding and Driving Prohibited**

63. No person shall drive any vehicle or horse at an immoderate rate or rate that is unsafe or improper under the conditions then existing and any person riding or driving along any street shall slacken his speed in approaching any crossing for foot passengers upon which any person may be.

### **Vehicles not to be Driven on Sidewalk**

64. No person shall run, draw or push any vehicle upon any sidewalk.

### **Littering**

65. (1) Except by resolution of the Council no person shall either himself or herself through any person, place, put or leave any animal, vehicle coal, lumber, building material, firewood, goods, wares, merchandise or thing of any kind whatsoever upon or in any way directly or indirectly encumber, obstruct, injure or foul any street, lane square, walk, sidewalk, road, bridge, ditch gutter, drain or sewer, except as herein and in the building bylaw of the Town provided, nor shall any person throw glass or bottles on any street.

(2) Except by resolution of the Council, no person shall either through themselves or through another person, put, place or leave or store any house trailer, any farm machinery, farm equipment, tractor or machinery of any kind upon or in any roadway or boulevard.

**Fuel not to be Placed on Sidewalk**

66. No person shall throw, place or pile cordwood, firewood, coal or other fuel upon any sidewalk, except for the purpose of immediately storing same; and no person shall saw or split cordwood or firewood upon any street or sidewalk nor shall any person being the owner of cordwood, firewood, coal or other fuel which has been thrown or piled upon any street or sidewalk permit the same to remain thereon for a longer period than six (6) hours.

**Water Escaping from Premises**

67. (1) If an owner or occupant of any premises shall allow water to escape onto the sidewalk adjacent to said premises or adjoining premises and remain on the said sidewalks in the form of ice, the said owner or occupant shall cause the said ice to be removed forthwith; provided, however that in the event of it being impossible to remove said ice without injury to the sidewalk, then the owner or occupant shall be excused from removing same if he shall have covered all such ice with sand, ashes or other non-slip material and keep the said sidewalk in a fit and proper condition for pedestrians until he does remove said ice.

(2) No person shall by himself or his agent remove or cause to be removed any sand, ash or other non-slip substance from any sidewalk unless he shall at the same time remove all snow and ice from such sidewalk and leave the same in a safe and proper condition for pedestrian traffic.

**New Sidewalks not to be Walked On**

68. No person shall walk upon newly constructed sidewalks or pavements before they have been opened for public traffic by the Town Foreman.

**Defacing Signs**

69. No person shall pull down or deface any signs or any printed or written notice legally placed.

**Removal of Hedge**

70. The Council may, upon a report of a police officer that a hedge or tree situated on private property and located on a street corner is dangerous to traffic, by resolution order that such hedge be removed or cut to such a height as it may direct.

**Penalty – Weight Restriction, Truck Route**

72. (1) A person who contravenes the provisions of subsection (56), is guilty of an offence and liable on summary conviction to a penalty of not less than \$100.00 nor more than \$200.00 for the first offence and no less than \$200.00 nor more than \$500.00 for each subsequent offence.

(2) A further penalty shall be imposed as follows:

- (a) three dollars (\$3.00) for each 50 kg. or fraction thereof for the first 1,000 kg. in excess of the prescribed maximum gross weight allowable, and;
- (b) five dollars (\$5.00) for each 50 kg. of fraction thereof in excess of 1,000 kg. that the actual gross weight exceeds the prescribed gross weight allowable, provided that in computing the further penalty, 500 kg. or two per cent (2%) of the maximum gross weight fixed by this bylaw, which ever is the lesser, shall not be taken into account.

73. (1) Where any person has committed or is alleged to have committed a breach of any of the sections of this bylaw specified in Section 71 hereof, a ticket in a form to be approved by a police officer employed or acting under the authority of the Town of Fort Qu'Appelle may be served on such person. Such person may pay to the Town Clerk at Fort Qu'Appelle, in lawful money of Canada an amount equal to the penalty fixed for the respective Sections specified in Section 71 provided that payment must be made within a period of from the service of said ticket. If payment is made within such time and accepted, then the person shall not be liable to prosecution for the offence.

(2) Service of such ticket may be made by attaching same to the vehicle in respect of which an offence has been committed or by mailing such ticket addressed to the registered owner of the vehicle concerned, or by personal service on the person who has committed the offence.



(3) If the person given such ticket fails to pay the specified penalty within the time allowed, then the provisions of this Section shall no longer apply and the person shall be liable to prosecution for the offence in the ordinary way, provided that nothing in this Section shall prevent any person served with such ticket from exercising his right to defend any of these particularized offences.

**General Penalty**

74. Any person guilty of a breach of any of the provisions of this bylaw for which no specific penalty is provided by subsection (1) of Section 71, is liable on summary conviction to a penalty of not less than forty dollars (\$40.00) nor more than one thousand dollars (\$1,000.00) and in default of payment to imprisonment for a term not exceeding six months. In the case of a corporation of a fine not less than forty dollars (\$40.00) and not more than two thousand dollars (\$2,000.00).
